

Game Changing Technologies in Mobility

Last IT (disruptive) advancements influence all domains:

- Big Data -> ITS: control and enforcements

Our mission...


...is to leverage, popularise and mainstream the concept of a **public-private integrative co-modal local transportation service**...




3 Test-levels

- ✓ Test C: On site real experiments 3 sites




